GENERALLY

4.010 Types of terms. The terms of the circuit courts are either those appointed by law, or others appointed by a judge of the court.

REGULAR TERMS

4.110 First district. The terms of the circuit court in the first judicial district shall be held at the county seats of the respective counties of the district at the following times: Josephine County, second Monday in January, second Monday in April, second Monday in July and second Monday in October; Jackson County, third Monday in January, third Monday in April, third Monday in July and third Monday in October. A jury shall be summoned for each regular term.

4.120 Second district. The terms of the circuit court in the second judicial district shall be held at the county seat of Lane County at the following times: First Monday in January, first Monday in March, first Monday in May, first Monday in July, first Monday in September, and first Monday in November.

4.130 Third district. The terms of the circuit court in the third judicial district shall be held in Marion County at the following times: First Monday in January; first Monday in April; first Monday in July; first Monday in October.

4.140 Fourth district. The regular terms of the circuit court in the fourth judicial district shall be held in Multnomah County at times designated by order of the court concurred in by a majority of the judges thereof. The order shall be made and entered of record each year, and may be amended by making and entering of record further orders. There shall be at least 10 regular terms each calendar year.

4.150 Fifth district. The terms of the circuit court in the fifth judicial district shall be held at the county seat of Clackamas County at the following times: First Tuesday in January; first Tuesday in March; first Tuesday in May; first Tuesday in July; first Tuesday in September; first Tuesday in

November. At the July term, no jury shall be summoned unless the judge, at least 20 days before said term, files with the clerk of the court an order directing that a panel be drawn.

4.160 Sixth district. The terms of the circuit court in the sixth judicial district shall be held at the county seats of the respective counties of the district at the following times: Umatilla County, first Monday in January, first Monday in April, first Monday in July and first Monday in October; Morrow County, second Monday in June and second Monday in December.

4.170 Seventh district. (1) The terms of the circuit court in the seventh judicial district shall be held at the county seats of the respective counties of the district at the following times:

(a) Hood River County, first Monday in March, first Monday in July and second Monday in November.

(b) Sherman County, third Monday in April and third Monday in October.

(c) Wasco County, second Monday in February, fourth Monday in May and fourth Monday in September.

(2) The regular terms of court in Sherman County shall be jury terms.

4.180 Eighth district. The terms of the circuit court in the eighth judicial district shall be held at the county seat of Baker County at the following times: First Monday in February; second Monday in June; first Monday in November.

4.190 Ninth district. The terms of the circuit court in the ninth judicial district shall be held at the county seats of the respective counties of the district at the following times: Malheur County, first Monday in April, first Tuesday in September and first Monday in December; Harney County, first Monday in February, first Monday in June and first Monday in October. For the June term in Harney County, a jury shall not be summoned except by order of the circuit judge.

4.200 Tenth district. The terms of the circuit court in the tenth judicial district shall be held at the county seats of the respective counties of the district at the following times: Union County, first Monday

in February, first Monday in June and first Monday in October; Wallowa County, second Monday in May and second Monday in November.

4.210 Eleventh district. (1) The terms of the circuit court in the eleventh judicial district shall be held at the county seats of the respective counties of the district at the following times:

(a) Crook County, second Monday in March and third Monday in September.

(b) Deschutes County, first Monday in April and first Monday in November.

(c) Gilliam County, first Monday in June and first Monday in December.

(d) Grant County, third Monday in March and first Monday in September.

(e) Jefferson County, second Monday in May and first Monday in December.

(f) Wheeler County, first Monday in April and first Monday in October.

(2) The regular terms of court in Gilliam, Grant and Wheeler Counties shall be jury terms.

4.220 Twelfth district. The terms of the circuit court in the twelfth judicial district shall be held at the county seats of the respective counties of the district at the following times: Polk County, first Monday in February, April, June and November; Yamhill County, first Monday in March, May and December and the second Monday in September.

4.230 Thirteenth district. The terms of the circuit court in the thirteenth judicial district shall be held at the county seat of Klamath County at the following times: Second Monday in January, second Monday in April, second Monday in July and second Monday in October.

4.240 Fourteenth district. The terms of the circuit court in the fourteenth judicial district shall be held at the county seat of Lake County at the following times: Third Monday in May and first Monday in November.

4.242 Fifteenth District. (1) The terms of the circuit court in the fifteenth judicial district shall be held at the county seats of the respective counties of the district at times designated by order of the court. There shall be not fewer than six regular

terms each calendar year in Coos County, and not fewer than three regular terms each calendar year in Curry County.

(2) The order provided for in subsection (1) of this section shall be made and entered of record in September of each year, and may be amended by making and entering of record further orders.

4.244 Sixteenth district. The terms of the circuit court in the sixteenth judicial district shall be held at the county seat of Douglas County at the following times: First Monday in January, first Monday in March, first Monday in May, first Monday in July, first Monday in September and first Monday in November.

4.248 Seventeenth district. The terms of the circuit court in the seventeenth judicial district shall be held in Lincoln County at the following times: First Monday in January; first Monday in March; first Monday in June and first Monday in October.

4.260 Nineteenth district. The terms of the circuit court in the nineteenth judicial district shall be held at the county seats of the respective counties of the district at the following times: Tillamook County, first Monday in February, May and October; Clatsop County, third Monday in January and October, second Monday in April, and first Monday in July; Columbia County, third Monday in January and October, second Monday in April, and first Monday in July.

4.265 Twentieth district. The terms of the circuit court in the twentieth judicial district shall be held each year at the county seat in Washington County on the third Monday in January and October, second Monday in April, and first Monday in July.

4.270 Twenty-first district. The terms of the circuit court in the twenty-first judicial district shall be held at the county seats of Linn County and Benton County at the following times: First Monday in January; first Monday in March; first Monday in June and first Monday in October.

SPECIAL TERMS

4.410 Power or duty to call special terms; procedure. (1) When a term of court is appointed by a judge it shall be done by a general order to that effect, made and entered in the journal during term time, or by a special order made and filed in vacation, for the trial of a particular cause or the transaction of certain business specified in the special order, a certified copy of which special order shall be served on the parties to the cause or business 10 days prior to such term. In the former case, at the court so appointed, any business may be transacted that could be transacted during a regular term, but in the latter case only such as is specified in the order.

(2) Any circuit judge of the third, seventeenth, nineteenth or twenty-first judicial

district may, by order entered in the journal of the court, convene special terms of court between regular terms, for the trial of actions, suits or other judicial proceedings, and may summon juries for such special terms.

(3) The judge of the circuit court for Gilliam, Grant, Sherman and Wheeler Counties shall convene a sufficient number of special or adjourned terms of court in the county to speedily adjudicate all equity cases and other matters which may arise between regular terms, and shall also convene special jury terms when necessary.
