187.010 Legal holidays; acts deferred to next business day. (1) The following days are legal holidays in this state:

- (a) Each Sunday.
- (b) New Year's Day on January 1.
- (c) Washington's Birthday on the third Monday in February.
- (d) Memorial Day on the last Monday in May.
- (e) Independence Day on July 4.
- (f) Labor Day on the first Monday in September.
- (g) Veterans Day on November 11.
- (h) Thanksgiving Day on the fourth Thursday in November.
- (i) Christmas Day on December 25.

(2) Each time a holiday, other than Sunday, listed in subsection (1) of this section falls on Sunday, the succeeding Monday shall be a legal holiday. Each time a holiday listed in subsection (1) of this section falls on Saturday, the preceding Friday shall be a legal holiday.

(3) Any act authorized, required or permitted to be performed on a holiday as designated in this section may be performed on the next succeeding business day; and no liability or loss of rights of any kind shall result from such delay.

187.020 Additional legal holidays. (1) In addition to those specified in ORS 187.010, the following days are legal holidays in this state:

- (a) The first Monday in February for the observance of Lincoln's Birthday.
- (b) Every day appointed by the President of the United States or by the Governor as a day of mourning, rejoicing or other special observance.

(2) Each time a holiday referred to in paragraph (b) of subsection (1) of this section falls on Sunday, the succeeding Monday shall be a legal holiday. Each time a holiday referred to in paragraph (b) of subsection (1) of this section falls on Saturday, the preceding Friday shall be a legal holiday.

187.025 Days of commemoration. The following days shall be days of commemoration but not legal holidays and shall be suit-

ably observed in schools:

(1) Admission of Oregon into the Union on February 14.

(2) Columbus Day on October 12.

187.030 Banks closing on Saturdays and holidays; negotiable instruments payable on holidays, effect on time of payment. (1) Any bank which elects to close on Saturdays under any Act permitting such closure shall not remain closed on any holiday enumerated in ORS 187.020 when such holiday occurs on Friday or the observance of which occurs on Monday.

(2) Any bank, which term, for the purposes of this section, includes any state bank, national bank, federal reserve bank, trust company, safe deposit company, mutual savings bank and savings and loan association, doing business in this state, may, at its sole option, remain open for business on any holiday as designated in ORS 187.020; but any act authorized, required or permitted to be performed at or by or with respect to any bank, as herein defined, may be performed on the next succeeding business day, and no liability or loss of rights of any kind shall result from such performance of business on such holiday.

(3) Negotiable instruments falling due on any holiday designated in ORS 187.010 or 187.020 shall be due and payable on the next succeeding business day.

187.110 Standard of time. (1) The standard of time for the State of Oregon shall be the United States standard of time as established by the Congress of the United States for any particular area of the state under the Act of March 19, 1918, (15 U.S.C. 261) except that from 2 a.m. on the last Sunday in April until 2 a.m. on the last Sunday in October the standard of time for any area of this state shall be one hour in advance of the standard established for that particular area by the Congress of the United States under the Act of March 19, 1918.

(2) No department of the state government and no county, city or other political subdivision shall employ any other time or adopt any statute, ordinance or order providing for the use of any other standard of time.
