**605.010 Breeding horses near dwellings or in uninclosed place.** No person shall breed any horses within 150 feet of any house or dwelling used wholly or partly as a dwelling house, in any city or town within this state. Such breeding must be done within a pen or corral inclosed by a wall or fence completely obstructing the view.

**605.020 Breeding pen to be fenced or walled.** Any person breeding horses or engaging in or maintaining and operating a pen or corral for breeding purposes within any city or town, shall surround such breeding place with a solid wall or fence not less than 10 feet in height.

**605.030 Bulls used for "public service" must be of pure blooded breeding.** No person shall offer for sale or use or offer for public service for fee, compensation or reward, any bull that is not of pure blooded breeding. The term "public service" as used in this section means the breeding of any cow not owned by the owner of the bull for fee, compensation or reward.

**605.040 Misrepresentation of pedigree; mutilation of certificate or proof of pedigree.** (1) No person shall:

(a) By any false representation and with

intent to defraud, obtain from any corporation, club, association, society or company organized in whole or in part for the purpose of improving breeds of cattle, horses, sheep, swine or other domestic animals, a false certificate of registration of any such animal in their herd register or other register, or obtain the transfer of any such certificate.

(b) Knowingly and with intent to defraud, give a false pedigree of any such animal.

(c) During the existence of any mortgage on or lien or charge against any such animal, spoliage, mutilate or destroy the registration certificates or proofs of pedigree, or so encumber the same that the animal covered thereby cannot, in connection with the records, rules and regulations of the corporation, club, association, society or company under which the animal is registered, be directly designated thereby.

(2) Violation of this section is a Class B misdemeanor. [1971 c.743 §300]

**605.990 Penalties.** Violation of ORS 605.010 or 605.020 is punishable, upon conviction, by a fine of not less than \$50 nor exceeding \$200 or by imprisonment in the county jail for not less than five days nor exceeding 90 days.
